Summary

DeHacker's objective was to evaluate the repository for security-related issues, code quality, and adherence to specification and best practices.

Possible issues we looked for included (but are not limited to):

- Transaction-ordering dependence
- Timestamp dependence
- Mishandled exceptions and call stack limits
- Unsafe external calls
- Integer overflow/underflow
- Number rounding errors
- Reentrancy and cross-function vulnerabilities
- Denial of service/logical oversights
- Access control
- Centralization of power
- Business logic contradicting the specification
- Code clones, functionality duplication
- Gas usage
- Arbitrary token minting



Issue Categories

Every issue in this report was assigned a severity level from the following:

Critical severity issues

A vulnerability that can disrupt the contract functioning in a number of scenarios or creates a risk that the contract may be broken.

Major severity issues

A vulnerability that affects the desired outcome when using a contract or provides the opportunity to use a contract in an unintended way.

Medium severity issues

A vulnerability that could affect the desired outcome of executing the contract in a specific scenario.

Minor severity issues

A vulnerability that does not have a significant impact on possible scenarios for the use of the contract and is probably subjective.

Informational

A vulnerability that has informational character but is not affecting any of the code.

If burn is called when `totalSupply` is 0, then the call will fail due to a divide by zero when calculating the amounts to be returned to the caller.

Recommendation

Check the current `totalSupply` and make an assertion.

Appendix

Finding Categories

Centralization / Privilege

Centralization / Privilege findings refer to either feature logic or implementation of components that act against the nature of decentralization, such as explicit ownership or specialized access roles in combination with a mechanism to relocate funds.

Coding Style

Coding Style findings usually do not affect the generated bytecode but rather comment on how to make the codebase more legible and, as a result, easily maintainable.

Volatile Code

Volatile Code findings refer to segments of code that behave unexpectedly on certain edge cases that may result in a vulnerability.

Logical Issue

Logical Issue findings detail a fault in the logic of the linked code, such as an incorrect notion on how block.timestamp works.

Checksum Calculation Method

The "Checksum" field in the "Audit Scope" section is calculated as the SHA-256 (Secure Hash Algorithm 2 with digest size of 256 bits) digest of the content of each file hosted in the listed source repository under the specified commit.

The result is hexadecimal encoded and is the same as the output of the Linux "sha256sum" command against the target file.
